MINIMUM QUALIFICATIONS

Education: Possession of a bachelor's degree in Nursing from an accredited college or university.

Experience: Four (4) years of progressively responsible clinical or administrative experience, including two years in a supervisory or management capacity.

Substitution: Possession of a master's degree in Nursing, Public Health, or closely related field may be substituted for one year of the required non-supervisory experience.

Licenses and Certificates: Possession of a valid registration as a nurse in the State of California and possession of a valid California driver's license.



TYPICAL DUTIES

- Plans, organizes, and coordinates the operations and services of Public Health Children's Medical Service Programs; identifies service needs and develops and implements corresponding programs; revises programs, as necessary.
- Selects, orients, assigns, trains, supervises and evaluates subordinate staff; recommends discipline as appropriate.
- Interprets and enforces county and state policies, procedures and contract requirements; determines eligibility for services, includes interpreting Medical and other payer regulations and procedures.
- Ensures that services rendered for clients are appropriate; provides case management direction to clients and families.
- Develops and administers department budget in accordance with state and county regulations; authorizes and monitors the expenditure of funds.
- Collaborates with and coordinates with State program administration and represents the Department in related meetings; interacts with the medical provider community.
- Prepares reports and correspondence; analyzes, compiles and reports statistical data.

APPLICATION and SELECTION

The competitive process includes submittal of a completed San Joaquin County Employment Application. If an exam is administered, qualified applicants will be invited to participate in an oral exam which may include a practical exercise. Candidates who successfully pass will be placed on the eligible list and the top scoring candidates will be referred to the department for a hiring interview.

To apply, a complete application package, including supplemental questionnaire, must be submitted to the Human Resources Department on or before the final filing date. Resumes are not accepted in lieu of a complete application.
