Tier one camps offer either food service, multiple programs, or single focus programs that involve but are not limited to firearms, challenge courses, archery or power tools. Food service is defined as either on-site food preparation or the distribution of non-prepackaged, potentially hazardous foods. Tier two camps are single focus and offer no food service. All camps will be required to file a notice of intent to operate with the local enforcement agency (LEA) including a written operating plan or written verification that the camp is accredited by the American Camp Association (ACA). LEAs must acknowledge receipt of the plans within 30 days. For Tier one camps, LEAs must issue a permit to operate for any camp that has an operating plan that includes appropriate health and sanitation standards, and the LEA must conduct an initial inspection of the camp premises to verify compliance of those health and sanitation standards. For Tier two camps, LEAs must issue a registration so long as the camp has submitted either its written plan or ACA accreditation. Both Tier one and Tier two camps must be in compliance with existing organized camp regulations (eg: water supply, building standards, firearms storage). Requires that either organizations hiring camp directors or LEAs must conduct a background check on a camp director. Tier one camps may be charged a fee for inspections. Camps may be cited for failing to meet any requirements and they may appeal a citation to the local health agency who must then respond within 30 business days. Any person alleging health or sanitation violations may file a complaint with the LEA; local enforcement agencies are required to investigate any complaint received and may charge a fee for any oversight activity mandated by the bill.
