Prohibits restrictions on the sales of these products. Requires manufacturers of these products to demonstrate that all parts of the plant used come from a state or country that has an established and approved industrial hemp program. Prohibits manufacturers of these products from including on the label, or publishing/disseminating any health-related information or statement. Creates requirements for the testing and labeling of these products. Unless explicitly approved by the federal Food and Drug Administration, industrial hemp may not be included in medical devices, prescription drugs, processed smokable products, including e-cigarettes with nicotine, smokable flower, including hookah and shisha with nicotine, and any product that contains nicotine, tobacco, or alcohol. Manufacturing enforcement to be conducted by the CA Department of Public Health and state, local, or law enforcement is allowed to review paperwork from those handling or transporting these products and take samples to test for verification.
