Dr. Geoffrey Leung, Public Health Officer

Dr. Geoffrey Leung serves as the Public Health Officer for Riverside County. At Riverside University Health System, he has previously served as the Ambulatory Medical Director, Family Medicine Department Chair, and Medical Staff President. Dr. Leung is a Health Sciences Clinical Professor of Family Medicine at the University of California Riverside School of Medicine. He is currently involved in community wellness, integration of health services, and whole person strategies for promoting health. Dr. Leung is passionate about Community Health, Health Equity, Social Determinants of Health, and Population Health.
